

# PECAN, an innovative approach to derogatory reimbursement of digital medical devices (DMDs)

### Overview

- New one-year transitional and temporary reimbursement access scheme
- Launched in April 2023



#### Scope

- Innovative DMDs for individual use
  - for therapeutic purposes (DTx)
  - remote Monitoring (TLS)
- With initial elements to assess the potential benefits of the solution before the end of PECAN



- Rapid access to digital health innovations for patients
- Operational deployment in parallel of procedures to get a standard definitive reimbursement

### □ How?

- Parallel evaluation process by HTA Agency (HAS) & Digital health agency (ANS)
- Authorisation decision by the Minister of Health
- Duration: 3 to 4
  months after candidate sub
  mission of file



# PECAN and DiGA, two pioneering mechanisms in the EU

In Germany, the Diga Fast Track has enabled accelerated market access for certain categories of digital health applications

Social Security Funding Law 2022 : Article 58
PECAN:



Therapeutic (DTx) or telemonitoring activities



Class I, IIa, IIb and III HAS (CNEDIMTS) and ANS evaluate PECAN applications



### One-year transitional reimbursement

predefined fixed compensation Negociated final price after 12 months (only for DTx) Telemonitoring prices are predefined (no negociation)





Therapeutic DMD (DTx)



Class I and IIa only **BfArM** evaluates Diga candidates



#### **One-year transitional reimbursement**

at manufacturer's price

Negociated final price after 12 months




















Parallel submission Evatech platform (HAS) on (ANS) and on Convergence platform and possibility of discussion with the instructors

- Possible types of discussion:
  - HAS:
- Early meeting to discuss a study protocol
- Pre-deposit meeting to discuss the construction of vour file


- ANS:
  - Contact ANS teams through the industrial contact form
- When the file is complete, Ministry of Health sends acknowledment of receipt
- Starts the official evaluation process by HAS and ANS




# How to benefit from the derogatory reimbursement —





- Start of the evaluation by HAS and ANS
- Opinions delivered to MoH and the candidate by the CNEDiMTS of the HAS and the ANS
- The instruction may be suspended when additional information is expected
- Every suspension (max 30d) is notified by the **Ministry of Health**






### PECAN decision tree towards derogatory reimbursement



- PECAN decision for a 1-year reimbursement by the ministers responsible for health and social security
- Commitment of the candidate to file its application for standard reimbursement and registration in the LPPR or the LATM, within a period of 6 months and 9 months respectively from the publication of the PECAN's order

# After a year of reimbursement

### End of the PECAN



- Validation for standard reimbursement
- After a year without validation nor refusal
- Absence of final evaluation submission within legal time limits, or withdrawal of the standard reimbursement application
- Refusal : Negative decision by the minister
- Non-compliance with the legal requirements regading CE marking, interopérability and security ANS conformity
- Removal form the market for serious reasons related to patient's safety by MDR competent authority in France (ANSM)



- Mandatory treatment continuity for the industrial, depending on the case:
- 6 months after the end of the temporary reimbursement
- 45 days after a refusal by the minister in the claimed indication
- Except for serious reasons related to patient safety
