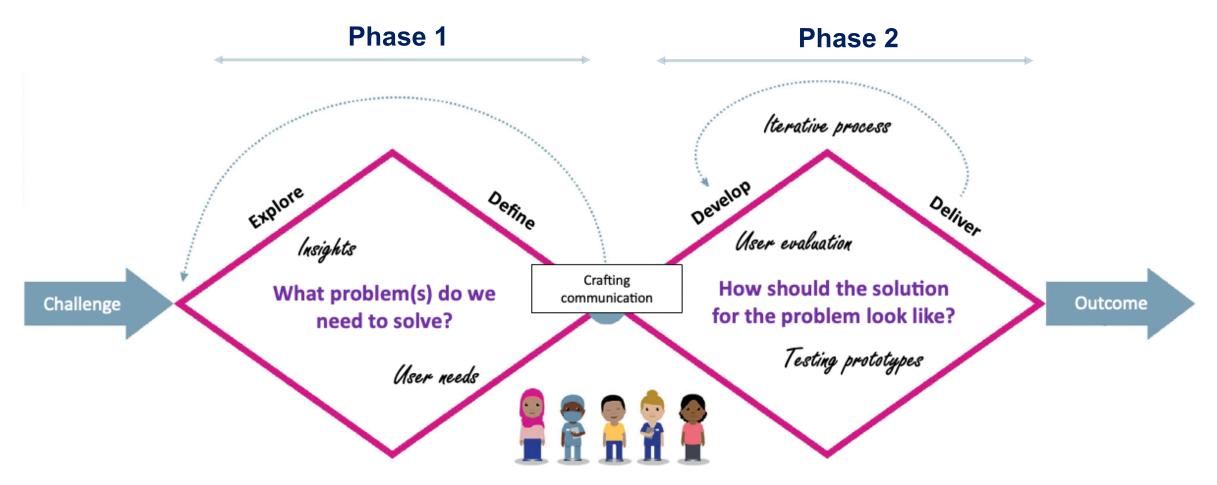

## **LABEL2** Setup of the subproject

- Developing communication prototypes by means of co-creation with the target group (i.e., patients, citizens, carers).
- Test whether the communication prototypes support understanding and informed decision making among the target group, and particularly among users with lower levels of health literacy.

### Aims

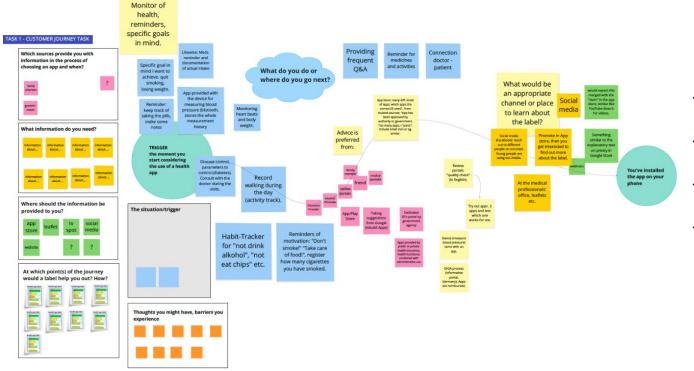
(1) To identify aspects that prevent understanding and informed use of the label that should be addressed in the supporting communication.(2) Collect input and insights for the supporting communication in terms of content, timing, and channels.

- (2) Mapping understanding of the elements of label and ranking importance
- (3) Choosing an app based on the label



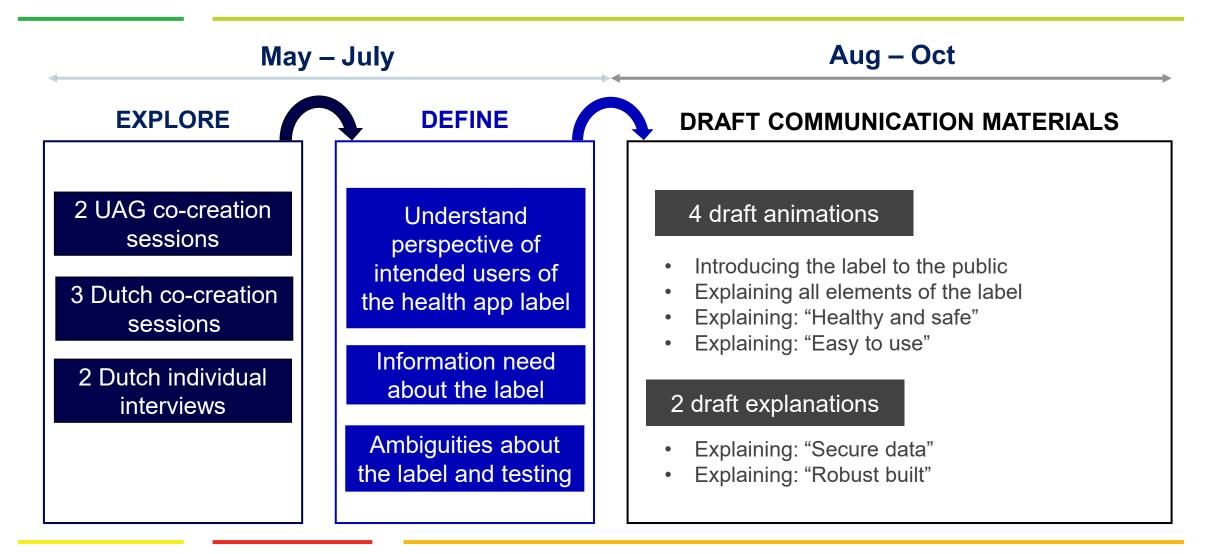
## LABEL2 . (1) Customer journey

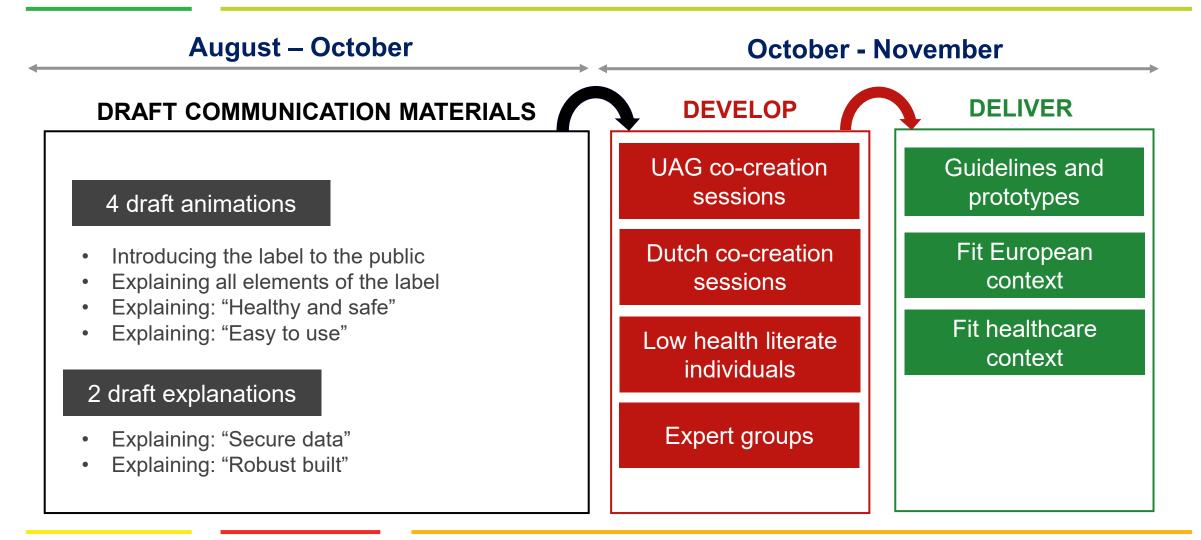
